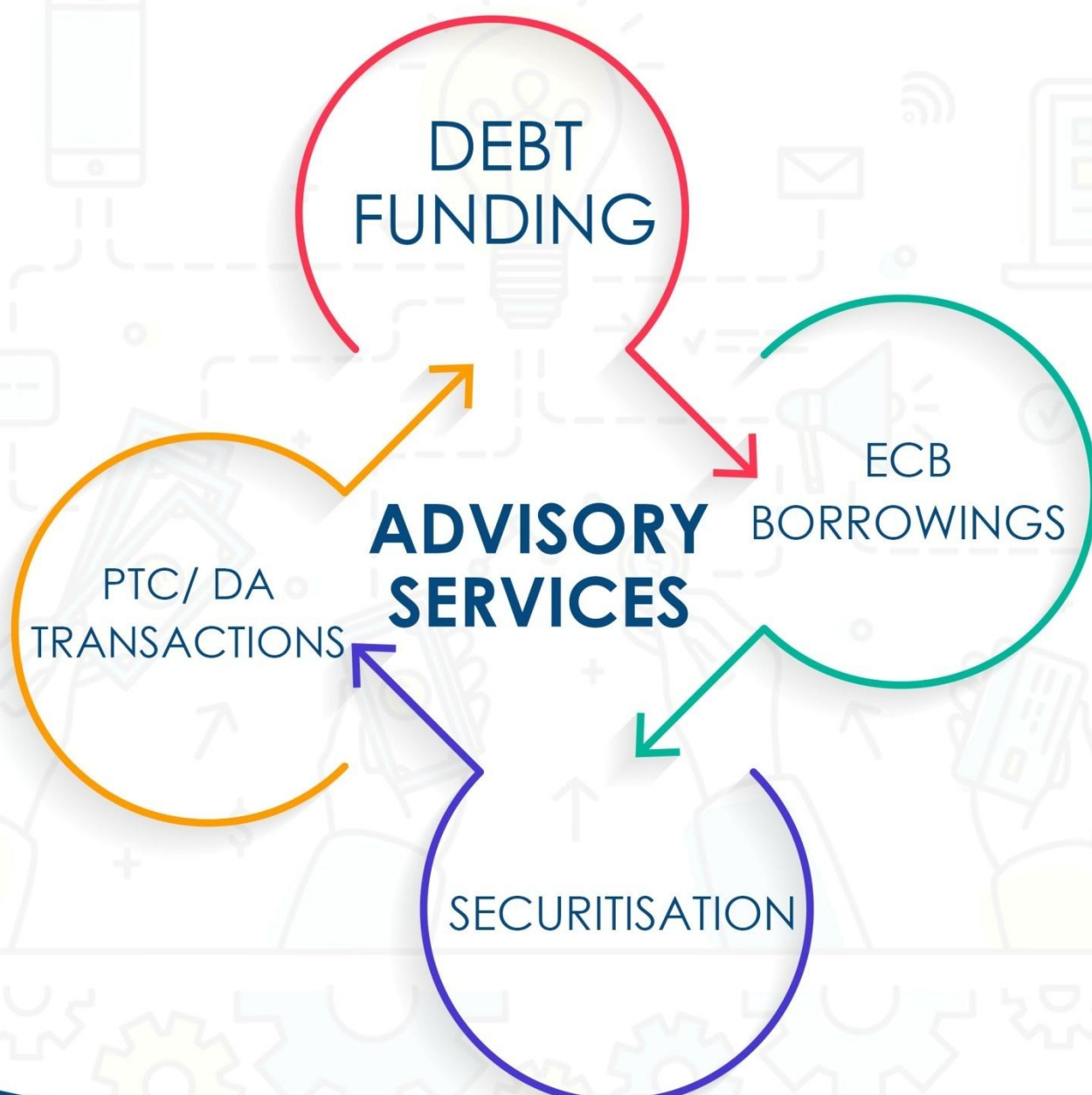

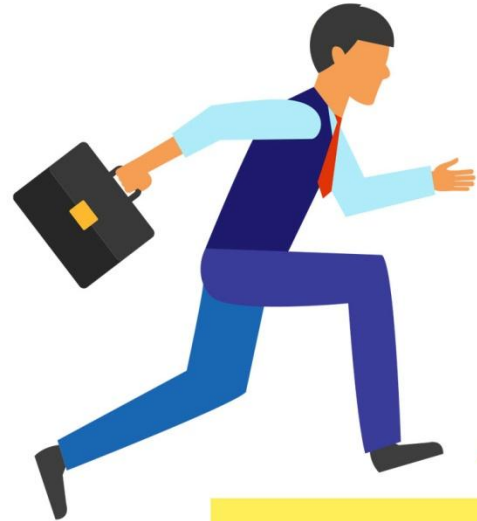

HORIZON FINANCIAL SERVICES will spend time with the Institution to gain a thorough understanding of the process and the related procedures to facilitate the Funding Requirements.

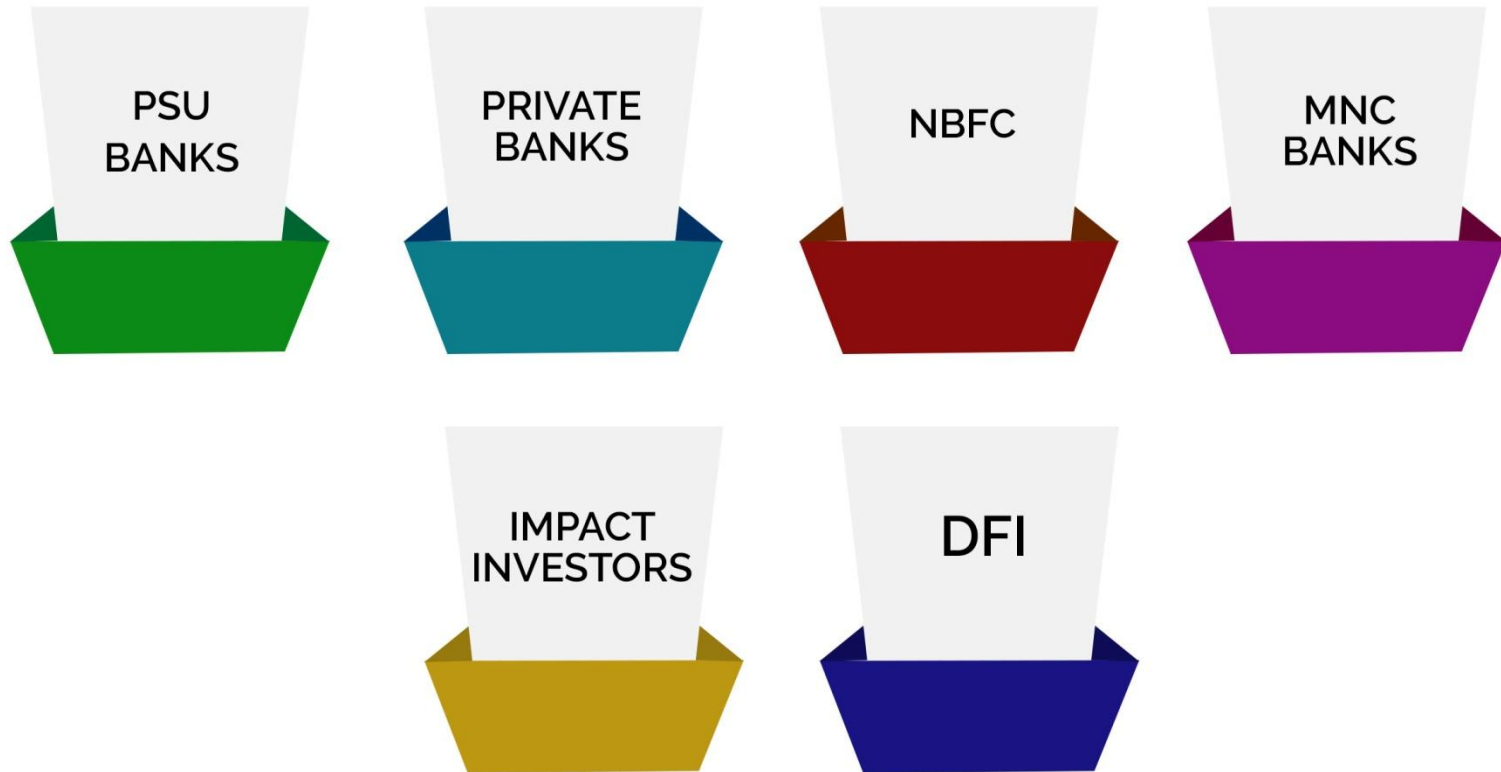
ASSIGNMENT
